Bryan,

VDEQ completed its review of the 03/17/14 redline version of the Second Five Year Review and offers the following comments.

1. Section 4.3.2: In the last paragraph, please revise the 2nd sentence as follows, "Additionally, an approximately 27-cubic-foot (ft³) sinkhole, observed in July 2011 on the southeast edge of the landfill, was filled with material removed to create the drainage swale, and re-vegetated."
2. Table 4-4: Similar to Sites 11a and 13, Site 7 remediation costs are outside the +50%/-30% range. Therefore, the Site 7 portion of the Summary Form and Sections 4.3.3 and 4.6 should be revised accordingly noting the path forward will be discussed, i.e., whether an ESD is necessary or not given the delay in LTM startup.
3. Table 5-4: Ensure the last sentence of "Action Taken" for "Issue" Annual GW Monitoring is revised as discussed (delete "will no longer be needed") during the 03/17/14 conference call.
