Per your request, please find enclosed two CDs containing the subject tables for your review and comment. These tables are being submitted in advance of the draft Lower Subbase Feasibility Study to expedite the review process. A CD containing the tables was also distributed to Mr. Mark Lewis at the CTDEP for his review and comment.

Each CD contains 112 ARARs tables. Tables 4-1 through 4-98 cover ARARs associated with soil remedial alternatives, Tables 4-99 through 4-107 address ARARs for groundwater remedial alternatives, and Tables 4-122 through 4-126 summarize ARARs for light-nonaqueous phase liquid (LNAPL) remedial alternatives. The ARARs tables associated with sediment remedial alternatives are not included in this submittal because of the ongoing resolution of the Thames River Validation Study by the Navy and another contractor. It is expected that the sediment ARARs tables will be submitted with the draft Lower Subbase Feasibility Study after the Thames River Validation Study is finalized.

In addition to the ARARs tables, each CD also contains three files that describe the soil, groundwater, and LNAPL remedial alternatives, respectively, associated with the ARARs tables. This information will help the reviewer understand the appropriateness of the ARARs for the associated alternative.
