Hi Team,

You are correct and Parris Island acknowledges it originally agreed to "MCRD Parris Island" and then requested "By Order of the Commanding General" instead of "MCRD Parris Island" be on the signs. "MCRD Parris Island" and "By Order of the Commanding General" were not included on the mock-up sign sent last Thursday because the sign maker at Parris Island informed us of the Base Exterior and Architecture Program at Parris Island which requires consistency among signs posted at Parris Island. The "NOTICE" sign is one of the "approved" sign formats for Parris Island. The other "NOTICE" signs around Parris Island do not have "MCRD Parris Island" or "By Order of the Commanding General". We also looked up what a SCDHEC sign looks like and noticed a SCDHEC sign does not look at all like the Parris Island sign (see attached). Note: the SCDHEC sign has "SCDHEC" on it in at least three places. The Colonel considered the Base Exterior and Architecture Program and the fact that SCDH

EC signs do not look like the Parris Island sign and decided not to include "MCRD Parris Island" or "By Order of the Commanding General" on the signs to be posted around 3d Bn Pond.
