**INVITATION TO COMMENT AND TO ATTEND A PUBLIC MEETING
PROPOSED PLAN FOR INSTALLATION RESTORATION SITE 21,
INDUSTRIAL AREA
St. Juliens Creek Annex
Chesapeake, Virginia**

The Navy Installation Restoration Program invites public comment on its Proposed Plan for a remedial action at Installation Restoration Site 21 at St. Juliens Creek Annex, Chesapeake, Virginia. As per the Code of Federal Regulations, 40 C.F.R. § 300.430(f)(2), the Proposed Plan presents assessments of risk to human health and the environment, summarizes the remedial alternatives considered for Site 21, and presents the rationale for selection of the preferred remedial alternative. The preferred remedial alternative outlined in the Proposed Plan is groundwater treatment through in situ chemical reduction and enhanced reductive dechlorination, and performance monitoring. Land use controls are also proposed for the site, to be maintained until site conditions allow for unlimited use and unrestricted exposure.

The Proposed Plan is based on findings contained in documents that are part of the Administrative Record for St. Juliens Creek Annex. The Administrative Record provides background information on Site 21 and summarizes remedial investigations conducted at the site.
