Thank you for giving the DEQ the opportunity to comment on the June 2014 *Site Management Plan, Fiscal Years 2015-2016* for CAX.

The SMP was received by the DEQ (electronically) on June 18, 2014.

The DEQ has the following comments:

AOC 2—Dextrose Dump

The final UFP-SAP to collect [WS1] additional surface and subsurface soil samples to refine the removal area footprint was submitted in May 2014, with subsequent fieldwork and sample collection also completed in May 2014.

AOC 6—Penniman AOC
Waste Slag Material

The CAX Partnering Team: agreed to remove the waste slag pile at AOC 6; has [WS2] determined that the soil and groundwater at the Waste Slag Material subarea of AOC 6 poses no potential unacceptable risk to human health and the environment; and concurred [WS3] that no action following the removal of the waste slag pile is required (CH2M HILL, 2013d).

- Waste Slag Material subarea – Removal and CERCLA activities are complete [WS4]

Upon your acceptance of the requested revisions and upon review of and concurrence with the additional proposed updates, the DEQ will issue an official letter for your files.
