**Naval Weapons Station Yorktown**

The U.S. Department of the Navy (Navy) announces the availability of the No Further Action (NFA) multi-site Record of Decision (ROD) for Site 4 (Burning Pad Residue Landfill), Site 21 (Battery and Drum Disposal Area), and Site 22 (the Burning Pad) and the ROD for Site 32 (Wetlands Area Downgradient of Beaver Pond), located at Naval Weapons Station (WPNSTA) Yorktown, Yorktown, Virginia. These RODs document the Navy's cleanup plan for groundwater, surface water, and sediment at Sites 4 and 21 and surface water and sediment at Sites 22 and 32, which consist of no further action for protection of human health or the environment.

The Sites 4, 21, & 22 and the Site 32 RODs were issued jointly between the Navy and the U.S. Environmental Protection Agency and was reviewed and agreed to by the Virginia Department of Environmental Quality.

A public comment period on the proposed NFA cleanup plan for Sites 4, 21, and 22 was held between July 26 and September 9, 2010. A public meeting was held on August 18, 2010 to discuss any comments or concerns the public may have regarding this plan, but no members of the public attended. In addition, no questions or comments were received during the public comment period and this is documented in the Responsiveness Summary portion of the ROD. Final signatures for the Sites 4, 21, & 22 NFA ROD were completed on September 12, 2011.

A public comment period on the proposed NFA cleanup plan for Site 32 was held between February 20 and April 5, 2011. A public meeting was held on March 10, 2010 to discuss any comments or concerns the public may have regarding this plan, but no members of the public attended. In addition, no questions or comments were received during the public comment period and this is documented in the Responsiveness Summary portion of the ROD. Final signatures for the Site 32 NFA ROD were completed on September 12, 2011.

The Sites 4, 21, & 22 and Site 32 NFA RODs will be available for public viewing for 30 days (October 10 - November 9, 2011) in the WPNSTA Yorktown Information Repository in the York County Public Library at 8500 George Washington Memorial Highway, Yorktown, VA
