Good afternoon Moshood and Wade,
This revised document is getting out a little later than anticipated, but attached for your review are the WPNSTA Yorktown Site 34 Draft Final SAP files that have been revised in response to comments

on the Draft report. The complete set of figures and appendices (along with the current Laboratory ELAP certificates) will be included with the Final SAP. The following files are attached:

As discussed during our last conference call, we were mobilizing to the site this week and have started our field investigation. Initial field activities include soil sampling, followed by soil boring/well installation. As a reminder, there were no changes to the soil sampling activities based on comments on the Draft SAP. In regards to the monitoring wells/soil borings, we concurred with all comments and are installing an additional deep well and collecting deeper soil lithology data in response.
