Dear Mr. Hayworth:

The Department of Environmental Protection has reviewed the Final Statement of Basis for Solid Waste Management Unit (SWMU) 23, Jacksonville Shipyards, Inc., Naval Station (NAVSTA) Mayport, Mayport, Florida and concurs with the Navy's selected remedy: Land Use Controls (LUCs) with associated groundwater monitoring. These controls will restrict the site to non-residential use only. They will also serve to prohibit groundwater use or extraction and any interference with groundwater monitoring systems at the SWMU. The NAVSTA Mayport Environmental Department will ensure that these or similar instructions, processes, and requirements are complied with for all activities at SWMU 23 under the NAVSTA Mayport site approval process and/or the excavation permit process.
