The Division of Solid Waste Management (the Division) has reviewed your request to modify the IM work plan that was submitted May 4, 2012 and approved by the Division on May 11, 2012. The original areas in Sub-Plume A proposed for injections of carbon substrate have seen decreases in trichloroethylene concentrations over the past two years. However, there are other areas in Sub-Plume A that may require injections.

You are requesting additional time to evaluate analytical data from the upcoming August 2013 sampling event to determine what locations, if any, would be appropriate for injecting substrate. The Division approves the modification to the IM Work Plan.
