SUBJECT: DISESTABLISHMENT OF THE NAVAL SUPPORT ACTIVITY
(NAVSUPPACT) MID-SOUTH RESTORATION ADVISORY BOARD (RAB)

The Navy and Community Co-Chairs of the NAVSUPPACT Mid-South RAB would like to propose disestablishment of the RAB, effective upon majority vote of its membership. Rationale for this proposal follows.

Since 1994, the RAB has served the city of Millington and surrounding communities by giving citizens a voice in cleanup decisions at NAVSUPPACT Mid-South. Many environmental sites have now been satisfactorily cleaned up and others have remedies already in place. The RAB has served its purpose well!

During the November 2005 RAB meeting, the Navy Co-Chair brought up the possibility of disestablishing the RAB sometime in the near future. A RAB community member requested that the RAB continue for at least another year. Since November 2005, there has been no request either from the Navy or from the community to reconvene the RAB.


Accordingly, consistent with Section IX of the RAB Charter entitled "Charter Termination", the Navy and Community Co-Chairs recommend that we disestablish the NAVSUPPACT Mid-South RAB upon receiving majority approval of this proposal by the current RAB membership.

The Co-Chairs do not plan to convene a RAB meeting solely for the purpose of approving or rejecting this proposal. Rather, you are asked to contact Mr. Rob Williamson of NAVFAC Midwest Public Works Department Mid-South, Environmental Division, at (901) 874-5399, or email rob.williamson@navy.mil, to cast your vote. A non-reply will be considered an approval of this proposal. We would appreciate your response within 30 days after receiving this letter.

Should the majority of RAB members decide to disestablish the RAB, please let us reassure you that we will continue to research and respond to any environmental restoration questions or concerns that you may have in the future. Our achievements over the last few years have been due largely to the excellent partnership between the Navy and the Community. We wish to sustain that relationship through cooperative action.

Your membership and support of the RAB has greatly facilitated the environmental cleanup program at NAVSUPACT Mid-South. We would like to take this opportunity to commend you for a job well done! Again, our thanks are extended to you for your willingness to represent the communities' interests during the environmental cleanup of NAVSUPACT Mid-South.
