The Division of Solid Waste Management (Division) is approving recommendations contained in the above referenced document. Soil samples collected at depths ranging from six to ten feet below ground surface and analyzed for benzene, toluene, ethylbenzene, xylene methyl tert-butyl ether, and naphthalene showed no detections above relevant action levels. These results confirm that the tank closure performed in 1992 removed all contaminated soil associated with SWMU 22; therefore, no further action is required.
